## Abstracts

Yoshiki Kinoshita: Cluster in the Loop Simulation Framework based on Formal Model-based Testing for Embedded Network Systems

Embedded network systems are growing all around the world, such as in-vehicle networking systems, consumer electronic networks and building energy management systems. Accordingly, verification and validation of embedded network systems are important to guarantee safeness and dependability, it however faces difficulties due to (1) increasing complexity of system functionality, (2) growing network scale, (3) increasing embedded devices, and (4) numerous combination of embedded environment to be considered for validation and verification. To handle the difficulties, we plan to develop a new system to validate embedded network systems using cluster in the loop simulation (CILS) approach and formal model-based testing. For this purpose, we have started a collaborative project with AIST, Daikin Industries, Ltd. (hereafter referred as Company D), and Renesas Technology Corp. (hereafter referred as Company R). Both Company D and Company R are Japan's leading companies, which respectively develops air-conditioning and building energy management systems and products embedded micro processing units and related development tools. In this paper, we explain the idea of cluster in the loop simulation and formal model-based testing and give the outline design of a CILS system based on formal model-based testing for a real building energy management system (BEMS) developed by Company D.

## Dirk Pattinson: Coinduction in Proof Theory: Efficient Algorithms for Satisfiability Checking

Tableau methods are one of the main techniques that underly automated reasoning for modal logics, and are implemented in an ever growing number of tools. Despite the fact that tableau algorithms work extremely well in practice, they often do not meet the known complexity bounds for the logics in question. Recently, it has been shown that optimality can be obtained for some logics while retaining practicality by using a technique called "global caching". Here, we show that global caching is applicable to a wide class of modal logics, including all those that can be equipped with coalgebraic semantics.

Starting from a sound and complete tableau calculus (and a set of global assumptions) we introduce two concrete algorithms to decide satisfiability. Both algorithms are proved correct coinductively, and can be seen to generalise ancestor equality blocking, and global caching, respectively. Apart from giving a coinductive reconstruction of ancestor equality blocking and global caching, this showcases the wide applicability of both and demonstrates that automated reasoning with coalgebraic logics in the presence of global assumptions is also in practice not (much) harder than for modal logics with an underlying relational semantics.

## John Power: Lawvere Theories over a General Base

The notion of Lawvere theory can be characterised by the presence of a structure-respecting equivalence between the category of Lawvere theories and the category of finitary monads on **Set**. The notion of monad extends from **Set** to any base category **C**, and the notion of finitariness extends to any base category **C** that is locally finitely presentable. Moreover, this all enriches. But what about the notion of Lawvere theory?

In this talk, we extend the notion of Lawvere theory, while retaining the spirit of the definition, to an arbitrary locally finitely presentable base category **C** in a way that naturally extends the above equivalence of categories. Moreover, we do it in a way that routinely and naturally enriches.
